HOW TO APPLY

1. Pay the Expedite Q Service fee via PayPal on the [Global Entry webpage](#)

Please note: We cannot use your credit card to pay the service fee

Your credit card will be used to pay the US border authorities fee for background and security checks

2. Fill out this application form and save as a separate file on your desktop **OR** print off this application form and fill out by hand **in clear bold capitals**.

Please note: We do not accept postal applications

Expedite Q PROCEDURES

1. We scrutinize your application and inform you of any omissions;
2. We transmit your application to the United States Border Authorities;
3. We pay for your security checks using the credit card supplied on your application;
4. We send you login details for your Trusted Traveler profile ;
5. We advise you of the documents you must take to your interview;
6. At the interview your biometric data will be collected and the program will be explained in full;
7. You can use the Global Entry kiosks when you receive your membership card 7-10 days later;

Expedite Q TERMS & CONDITIONS

1. Each applicant must ensure that they understand Expedite Q Services terms and conditions before submitting an application and paying the service fee;
2. Expedite Q Services is not a government agency;
3. Expedite Q Services is not responsible for applications, which are denied or delayed by the United States Border Authorities;
4. Expedite Q Services give refunds to applicants whose applications have not been submitted to Expedite Q Services or whose applications have not been processed by Expedite Q Services or whose applications have been submitted with errors by our agents;
5. All data submitted to Expedite Q Services is kept private and is deleted from the database after 60 days;
